Public Affairs Update

John Robinson called into the meeting to report the legislature did approve the Safe Harbor provisions related to OHVA's willingness to accept ECOT students that were suddenly displaced by the closure of ECOT. Mr. Norton responded he had testified before the legislature with respect to the need for protection being offered as a result of this sudden increase in enrollment suffered by OHVA. OHVA is now the largest online school in Ohio and will likely face increased scrutiny.

9. Operations

a. Head of School Academic Report

Dr. Stewart presented the Board with a four-page report explaining the theme for FY 2019 is "Impact of Hope." Current enrollment is 12,800 students with 1,918 students in the 12th grade. Nearly 9,000 of the students are either new to OHVA this year or just enrolled for the first time last year. The school retained 93% of the teachers and staff from last year and the majority of the staff have been with the school for over five years. Dr. Stewart also provided a summary of some of the summer school highlights.

b. Budget Review

Ms. Diu reviewed the one-page document entitled OHVA Forecast to Budget Report. Because the high school special education population is increasing, the amount of funding has also increased. The current forecast shows an increase of \$676,117 in increased funding and a decrease of \$1.8 million in expenditures. Ms. Diu indicated that there was a credit with respect to curriculum delivery, instructional materials and computers based upon the contract provision that requires a credit be given whenever a student generates less than \$1,000 in funding. The current forecast now shows a deficit of \$7.9 million which is down \$2.5 million from the original budget approved in June.

12. Other Updates

OHVA is definitely the largest online school that is managed by K12 and may be the largest online school in the country.

Mr. Norton indicated he and Ms. Wise attended the Professional Development days being held at Kalahari last week. Ms. Wise expressed her amazement at how many staff members had been with the school for over 10 and 15 years. Mr. Norton again suggested that if Board members had an opportunity, they should attend either graduation or a PD of the entire staff to see the magnitude of this organization.
